all in all, very slow scientific progress and poor return on investment



even after paying to read, people are granted little or no reuse permission



libraries pay for journal subscriptions, or the public pays to read individual articles

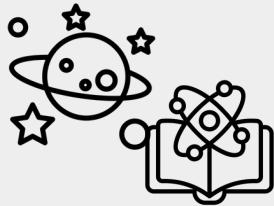

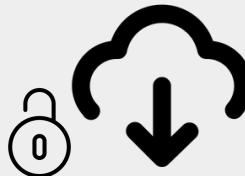

the public can download articles from open repositories

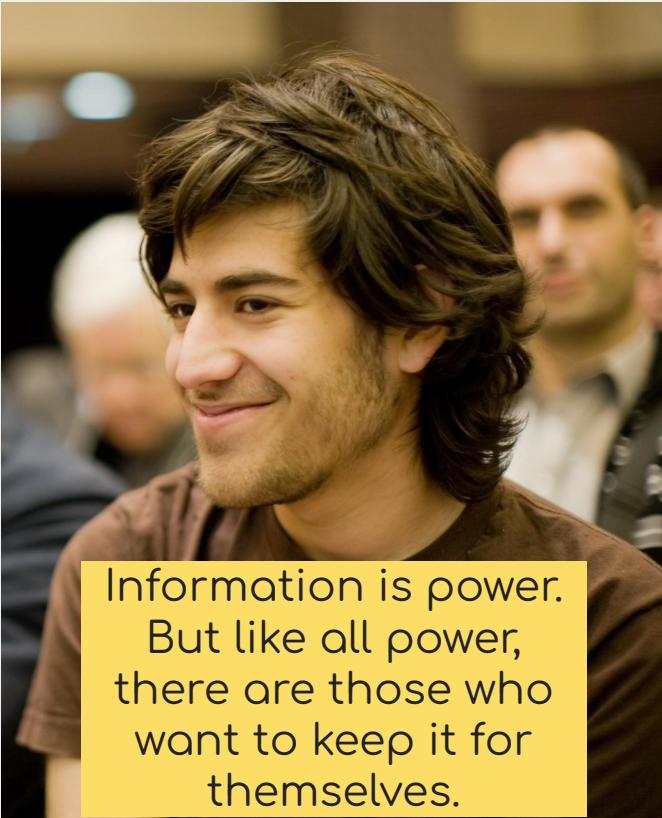

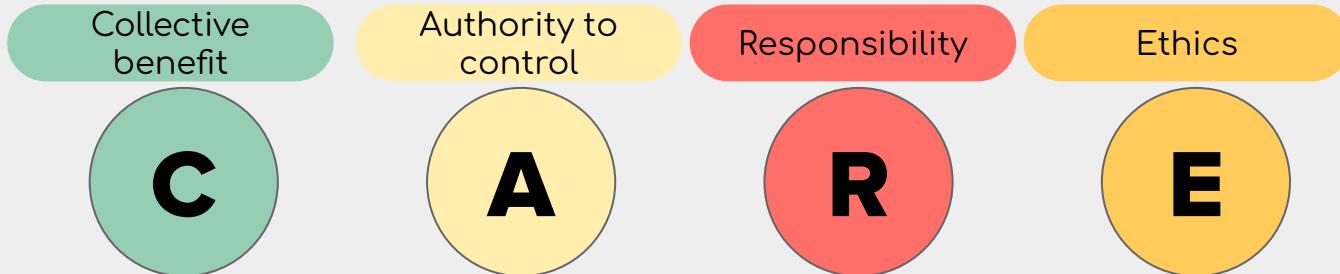
The FAIR Principles are aligned to the global shift towards open science and open data, promoting criteria that facilitate data sharing, while ignoring relationships, power differentials, and the historical conditions associated with the collection of data.

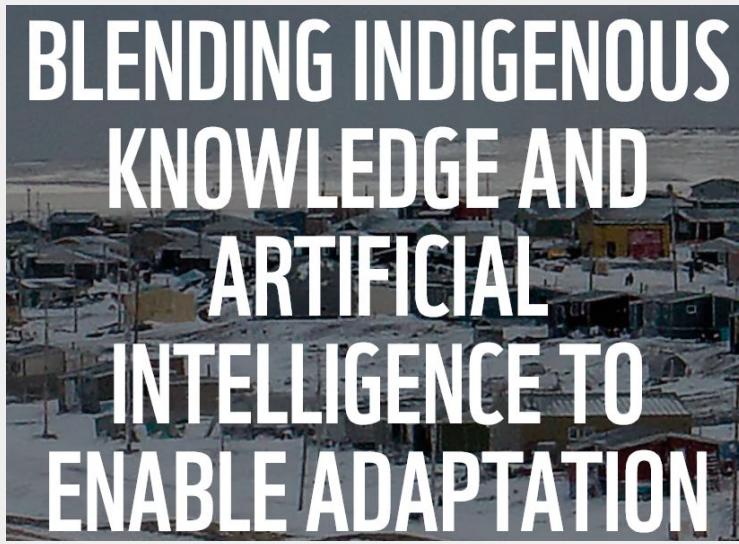


Operationalizing the CARE and FAIR Principles for Indigenous data futures

The CARE Principles speak to how scientific data are used in ways that are purposeful and oriented towards enhancing wellbeing of people.



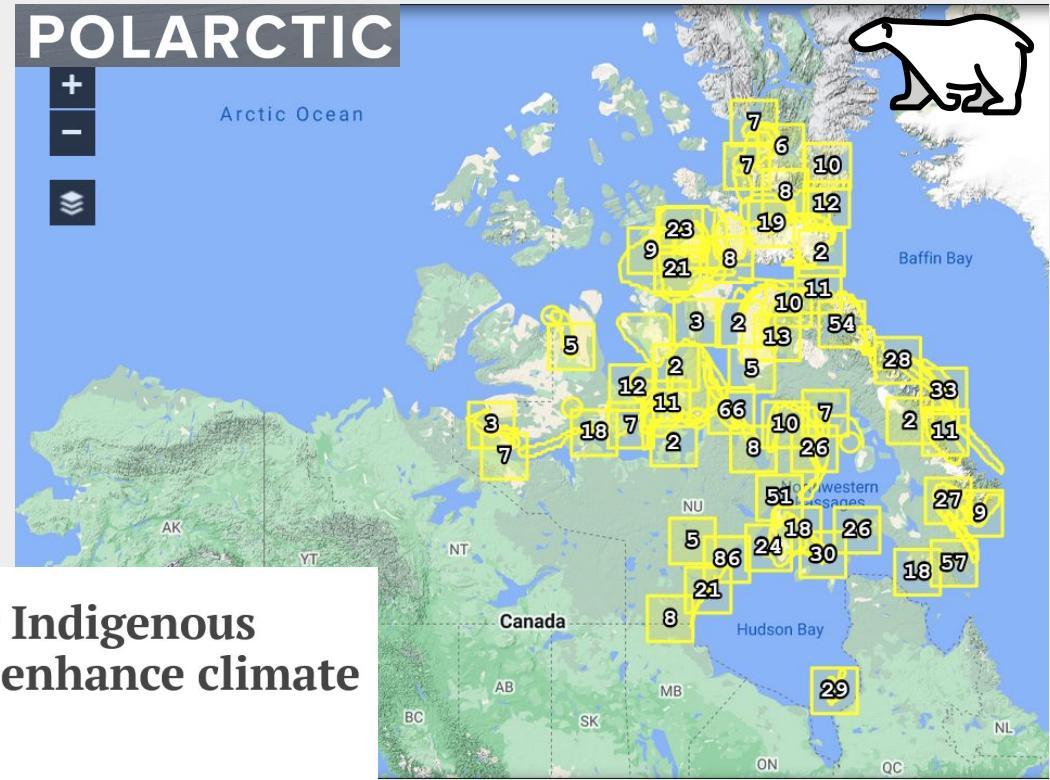

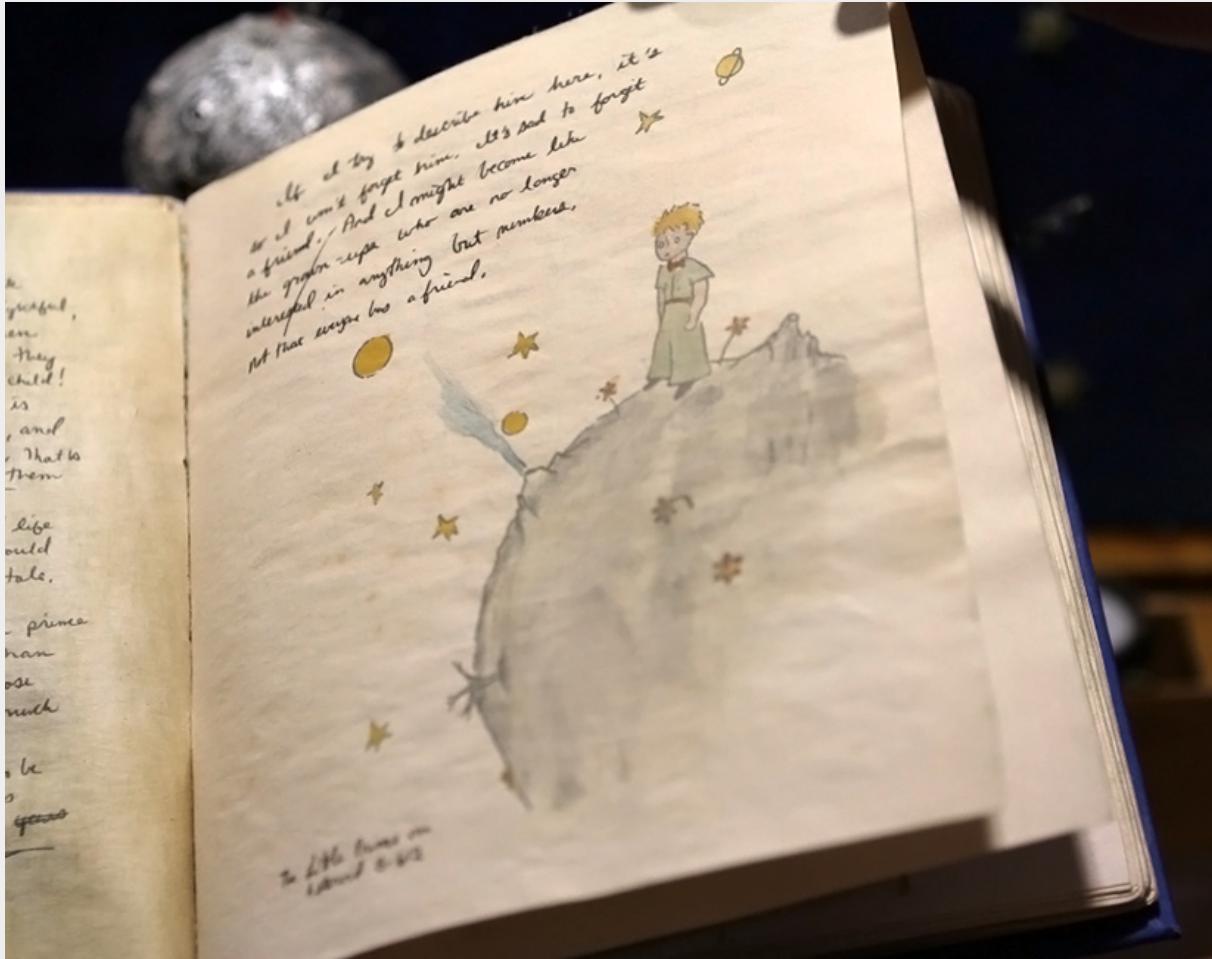
Researchers that can show proof of commitment¹ to our Code of Research Conduct, which emphasises open and replicable science, can become affiliated with IGDORE.



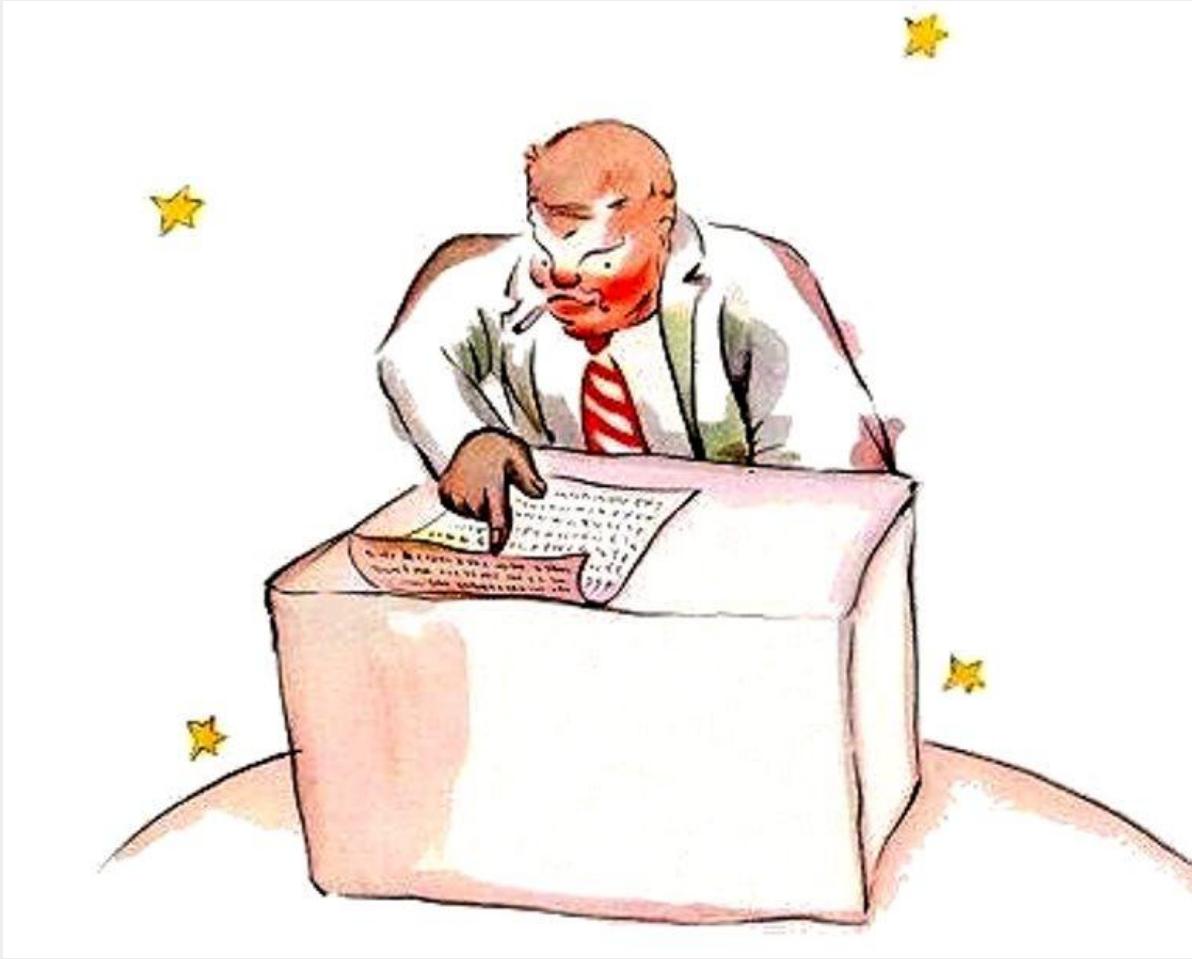

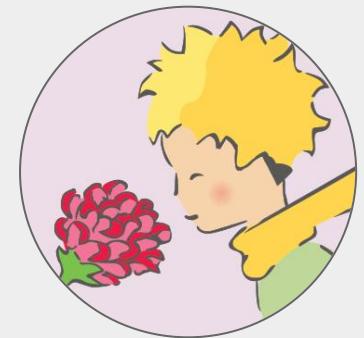
